2. Prorated membership dues are offered to new members only, on a one time basis.
3. Youth membership is offered to full time students, age 21 years or younger.
4. Associate membership is intended for social members or other non glider flying members.
5. Membership is granted after this application is approved by the Cleveland Soaring Society Board of Directors *and* membership dues are paid in full.
6. Membership is governed by the rights, limitations, policies and operating procedures listed in the corporation's bylaws and operations manual. These documents are available online for all members.
7. The corporation carries insurance on its fleet; however, members are liable for any deductible charges.
8. Personal medical insurance coverage for members is limited to \$1000.
9. To fly as Pilot in Command of a CSS aircraft, the pilot must meet all applicable current Federal Air Regulations issued by the FAA.

LEGAL WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

I, the undersigned, as a member, or the guest of a member, of the Cleveland Soaring Society, Inc. (hereafter known as CSS) wish to fly as pilot or passenger in a CSS aircraft or otherwise participate in flight operations or other CSS activities. I further confirm that I understand that participation in said activities may be hazardous and may result in accident, injury or death. I thereby voluntarily accept such hazard and result, both on my behalf and on behalf of my minor children whom I may bring to the operation areas of CSS, or permit to be carried in a CSS aircraft.

Therefore, in consideration of permission extended to me by CSS, through its officers and agents, to engage in flight activities or use of CSS property, equipment or services; I do hereby declare and decree that I, my family, my heirs, my executors and administrators:

- (1) Remise, release and forever discharge CSS and all its members, officers, directors and agents, acting officially or otherwise, from any and all claims, demands, actions or causes of actions arising out of or in any way, whether directly or indirectly connected with or related to CSS activity or use of CSS property, equipment or services, even though the loss, damage, injury, illness, or death may have been caused or brought about wholly or in part by:
 - (a) The sole, concurrent, active, passive, primary, or secondary negligence or gross negligence of CSS, including without limitation the CSS and all of its members, officers, directors or agents.
 - (b) The strict liability, strict products liability, breaches of express or implied warranties, and/or any other legal fault of the CSS and all of its members, officers, directors or agents.
 - (c) Any defect of any property or equipment of CSS, and including any defects preexisting the date of this agreement.

- (2) Agree to indemnify and hold harmless CSS and all of its members, officers, directors or agents, acting officially or otherwise, from any personal injury, illness or death claims brought by myself, my spouse or on behalf of my minor child(ren) arising out of or in any way, whether directly or indirectly connected with or related to CSS activities or use of CSS property, equipment or services, even though the loss, damage, injury, illness or death may have been caused or brought about wholly or in part by parties and/or causes set forth in subparagraphs (1)(a), (1)(b) and (1)(c) above.

I understand these statements hereby affirmed by me are contractual and not mere recitals. I have carefully considered the contents of this affirmation and release having read and hereby agree to each provision.
